"Rethinking Partnerships: Feminist and Inclusive Financing in a Shifting Global Architecture"

Context and Rationale

The international financial architecture is undergoing a deep transformation, driven both by the increasing economic constraints represented by the recent cuts by the United States and government and that are having a ripple effect on all cooperation in the Global North, and by the growing demands for deep systemic reform of fiscal affairs in several countries in the Global South.

This context is also characterized by a shrinking civic space, the resurgence of anti- gender movements and intensifying competition for limited resources. Feminist agendas -historically underfunded- now face increased pressure to prove their effectiveness and impact within new financial logics that increasingly emphasize efficiency, return on investment, geopolitical alignment, as well as restrictive fiscal reforms. This moment calls for bold and coordinated action to protect and scale up feminist financing models that place human rights, gender equality and sustainability at its core.

Within this evolving landscape, the French Support Fund for Feminist Organisations (FSOF¹ in its French acronym), led by the French Ministry of Foreign Affairs (MEAE) and the French Development Agency (AFD), has a strategic initiative that promotes a shift from conventional international cooperation to more flexible and transformative funding mechanisms that promote gender equality and strengthen grassroots feminist organizations, especially in the Global South.

Meanwhile, Mexico continues to champion multilateralism and feminist foreign policy, creating fertile ground for dialogue among governments, civil society, and emerging private actors on how to defend, finance, and expand feminist approaches to development. A truly inclusive and resilient financial architecture must not only integrate feminist priorities but actively protect them from dilution or marginalization in the evolving aid ecosystem.

Objectives

Foster inclusive dialogue among governments, feminist civil society, and the private sector to advance feminist-responsive and effective financing models grounded in principles of equity, international

cooperation, and feminist foreign policy.

- Analyze the risks and opportunities of the ongoing shift from traditional development aid toward "investments in solidarity and sustainability," particularly considering democratic backsliding, shrinking civic space, and declining resources for feminist organizations in the Global South.
- Highlight the strategic role of feminist intermediary funds in ensuring access to flexible, context-sensitive financing for grassroots movements advancing gender justice.
- Explore the evolving role of the private sector in feminist cooperation, acknowledging both its contributions and the need for accountability and autonomy in feminist agendas.
- **Develop joint policy proposals** among States, civil society, and private actors that embed gender justice, local ownership, and intersectionality in the reform of the international financial architecture.

Andrea Larios Campos is a feminist economist specializing in economic analysis and public finance with a human rights and gender perspective. She currently works as a researcher in the Fiscal Justice program at Fundar, leading projects on fiscal policy and economic, social, and gender justice. She co-coordinates the Feminist Fiscal Policy Network in Mexico, which brings together over 15 civil society organizations. Andrea holds a degree in Economics from Universidad Panamericana and is pursuing a Master's at UNAM. She previously worked at GBM and has published nationally and internationally, including contributions to the G20, International Budget Partnership, and outlets such as Nexos and El Universal. She has also participated as a panelist and lecturer in forums like IAFFE, ETFE, and CLACSO 2025.

NANCY HOUSTON - Feminists in Kenya (Prix Marianne 2025) – (IPPF - FON Project)

Nancy Houston is an international human rights lawyer, feminist organizer, and co-founder of Feminists in Kenya a social movement composed of Black and Queer feminist activists dedicated to amplifying feminisms as a theory and practice in Kenya. As a Chevening Scholar - the UK government's international awards program for developing future global leaders, she holds an LLM in International Human Rights Law from the University of Essex.

Through Feminists in Kenya, she has convened nationwide anti-femicide and anti- gender-based violence protests called #TotalShutDownKE, bringing together over 50,000 protesters since 2019. Their work focuses on four key themes:

Passionate about feminist philanthropy, Nancy has served as Africa Advisor for FRIDA the Young Feminist Fund and has supported the fund in distributing grants to grassroots feminist activists in Africa. Nancy is a 2025 Laureate of the Marianne Initiative for Human Rights Defenders launched by His Excellency the President of France, Emmanuel Macron.

Anuradha leads CREA's India operations, refining strategy and fostering innovative program designs responsive to national, regional, and global contexts. She has been actively involved in several regional feminist spaces such as the Agora and the African Feminist InstituteShe is also active in the Initiative for Reproductive Health, the Mauritanian collective "Voix des femmes" (Women's Voices), and the Réseau des Jeunes Féministes d'Afrique de l'Ouest (RJFAO) (West African Young Feminists Network).
